FISHING. New Licensing Regulations came into effect 01 Jan 93. Obtain details where you buy your licence. For Lower Beverley Lake, which is in Ministry of Natural Resources (MNR) Division 10:

My suggestion to anyone seeing fish being taken improperly: Speak politely and firmly to the offender. One could report details of date, time, place, description(s) of person(s), boat registration, vehicle description/plate to MNR, BROCKVILLE, 1-342-8524.

ASSOCIATION MEMBERSHIP. Please try to attend to the following as soon as possible. It would be helpful if your mailing could reach our Treasurer by 25 Jun 93, but late registrations WILL be accepted! (oVER --- OVER, please)

BEAVER PROBLEMS. I contacted MNR. They provide only advice. For individual trees, contact me and I'll send you their plan. ... To reduce the beaver population in an area, I think the best plan is for the land-owner to enter into a contract with a professional trapper. (Because there is little market for the pelts, a trapper will probably charge a basic fee, plus a bonus for (proof of) each animal trapped.) MNR assigns areas to trappers. ZEBRA MUSSEL has been reported in the Rideau system. It's definitely in the Great Lakes and I think I read of it being in some waters of New York State. MNR recommends: Do NOT transfer water from an infested system to an uninfested system. (In the earliest stage of their life cycle, ZM is invisible to the maked eye.) Before moving from one body of water to another, WELL AWAY from any body of water or sewage system, thoroughly clean anything which may have contacted water: fishing, scuba, skiing gear; boat hull and trailer; drain motor, bilge pump and live wells. CLEANING: Leave out of water in hot, dry weather for at least three days. OR Wash with hot water (40°C./102°F.). OR Wash with high pressure water (250 psi). AND, scrape off adult mussels (size of a finger mail).

PURPLE LOCSESTRIFE. This weed produces a tall and pretty flower spike, but it is destroying wetlands which act as water purifiers and provide habitat for desirable species. In some areas, experiments with imported insects which attack the weed are under way, but not in Ontario. So — wherever possible, remove and destroy PL. Try to get the roots, but at least get the tops before they produce thousands of seeds per plant. Take home/burn.

JET-SKIS. Because of their characteristic noise, they can be a problem to those who enjoy the sounds of nature on and around The Lake. The matter was discussed at the 1992 Annual Meeting. The Executive is gathering information. In the meantime, jet-ski users are URGED to operate safely and in sparsely populated areas of The Lake.

BOAT SPEED. At the Annual Meeting of 1992, it was decided that education is more feasible than legislation. The Executive is working on some possibilities. I'm sure that all cottagers will practise and encourage safe boating. A new law is that within 30 m (100 ft) of any shoreline, the maximum speed for a power-driven vessel is 10 km/h (6 mph). Unsafe boating, with detail of time, location and vessel description, should be reported to the Ontario Provincial Police: 1-800-267-8919. (Be prepared to assist/water-transport the investigating officer.)

MUNICIPAL TAXES. For the United Counties of Leeds and Grenville (in which the Townships of Bastard & South Burgess and Rear of Leeds & Lansdowne are located) the system of County-Wide Market Value Assessment may be implemented in 1994. The objective is to place all properties of the United Counties on the same base with respect to meeting needs at county level. I understand that at the moment, the matter is on hold, so that it may or may not occur in 1994. My guess is that the question most people have is, "Beyond the 'usual' increase, what will be the result on my taxes?" We'll try to have more information at the Annual Meeting on July 24, 1993.

SHORELINE WORK. "Natural" shoreline is greatly in the interest of the health of the water of The Lake. The proposed amendment to the Official Plan of Bastard & South Burgess requires restoration to more natural by the target date of 01 Dec 98. We'll try to have an up-date for the Annual Meeting of 24 Jul 93. ... Any alteration of a shoreline from natural NOW requires a permit from the MAR. Months of lead time are required.

SEWAGE SYSTEMS. It is in the interest of all users of The Lake if each of us ensures that our own sewage system is functioning efficiently. The proposed amendment of the Official Plan of B & SB requires up-grading to "least impact" standards by the target date of 01 Dec 96. If you'd like advice on evaluating your system, for direction to the proper authority, contact your township office. B & SB: (613) 928-2251; R of L&L: (613) 928-2423. For new and replacement systems, local suppliers and contractors should be aware of legal requirements and the systems which are most efficient and trouble-free. Glen A. And ... SOAP, SHAMPOO: Don't use them in The Lake; FERTILIZER: Don't use it near The Lake.
