### 8. WATER SAFETY/SAFE BOATING: Doug Kilpatrick

a. Safe Boating Events at LBL Township Park: A motion to approach the LBL Township Park to ban PWCs from launching at the park was made at the LBLA 1999 Annual General Meeting. Subsequent meetings with LBLA members and OPP led to the conclusion that this was not feasible. Rather, education in the safe and responsible operation of all types of watercraft would be the first step. A core group of LBLA members led by Doug Kilpatrick and with assistance and advice of OPP produced three publications (Safe and Considerate Boating, Reporting Boating Bad Behaviour, and Data Base of Watercraft Operated on Lower Beverley Lake & Creeks) for distribution through the LBLA annual newsletter and on-site distribution by LBLA volunteers and OPP at the park on three peak arrival weekends. On Victoria Day (May 20) two OPP officers and one cruiser plus five LBLA volunteers met incoming campers to disseminate information, gather data on entering watercraft, and show the public that the OPP and the LBLA care about safe and considerate boating on LBL and its creeks. On Canada Day (July 1), three OPP officers and three cruisers plus five LBLA volunteers were on hand. The weather was so good that the park was full with few new arrivals, so three teams (one OPP and one LBLA volunteer) circulated through the park distributing information, collecting data, and showing the flag. The third event is scheduled for August 5 (rain date September 2) and volunteers are welcome. The LBLA participants consider the exercise to be of value and very worthwhile.

### b. Boating Operator Competency:

All operators born after April 1, 1983 NOW (as of September 15, 1999) require proof of operator competency on board. All operators of craft under 4 metres in length, including PWCs, must have proof of operator competency on board as of September 2002.

Meeting attendees think Association should promote courses in the area, but there were no volunteers to co-ordinate this. Also suggested by attendee that course is offered on the internet. Kilpatrick also notes the bookmarks detailing information from the Safe Boating Guide, which were donated.

### 0. WATER LEVEL MONITORING AND CONTROL: Don Santos

Meeting with MNR's Dale McLenaghan who is trying his best, but it's hard keeping constant lake levels while receiving so much rain. As of 17<sup>th</sup> of July, lake is 8 inches over level set by MNR.

Sandy asks why are levels so high? Response: 4 inlets vs 1 outlet

Santos points out potential problems due to fluctuating water levels: to loons, boathouses, docks, shoreline erosion, increased weed growth.

Cheryl Curtis says she feels McLenaghan is very responsible and responsive.

### 11. LOWER BEVERLEY LAKE FISHERY: Don Santos

MNR responded to LBLA's voiced concern regarding the fishery at a meeting on June 17, 2000.

Highlights: LBLA's concern with commercial fishery misplaced, funding for fishery assessment in place to conduct Near Shore Community Index Netting in August. Mike Hart to develop formal proposal of regulation changes regarding pre-season angling for bass. Ted Brett and Clyde Bressler volunteered to work on creel diaries to be implemented in 2001.

### 12. FISH AND WILDLIFE GUARDIAN PROGRAM: Doug Kilpatrick

The programme was instituted to in part compensate for the reduction in Conservation Officers resulting from the Provincial Government's reduced funding to MNR. It also provides another means for local groups to be proactive in the care of local natural resources. The role of the F & W Guardian is to:

Aid Conservation Officers in upholding the Fish and Wildlife Conservation Act

Be positive and proactive in giving information, answering questions on angling and/or hunting

Be visible and accessible to the public

Be non-confrontational and do not engage the public in any enforcement activity

Be an observer, and pass information to the Guardian Co-ordinator for possible enforcement

Highlights: Ted Brett passed the qualification exam (first in his class). When on duty, F&W Guardian wears a clearly identifiable orange vest and hat. Anyone wishing to report a violation should contact Crimestoppers 1-800-222-TIPS.

### .3. WATER QUALITY: Don Santos

Long term trend is generally favourable. Tests are slightly better than last year or the same. Lower Beverley Lake is still ranked in the bottom 5% for clarity, and bottom 10% for phosphorus, but is much improved since the early 1990's when LBL was one of three lakes with poorest water quality. Lake Stewardship pays for additional testing. Len Vincent is testing Upper Beverley Lake.

Discussion: Zebra mussels will affect water quality, fishery, clarity, biodiversity etc. Griffith asks if there is any permissible weed control. Santos suggests to check with MNR/MOEE. Timmings asks where the source of phosphorus is and is anything being done about it.

### 14. TOWNSHIP/LAKE ASSOCIATIONS PROPOSALS: Doug Kilpatrick

At the spring meetings of the Alliance of Rideau Lakes Associations (ARLA) and the Cataraqui Region Lakes Stewards Network (CRLSN) the following motions were passed:

- Safe Boating: Navigation lights must be shown after sunset and before sunrise and in periods of reduced visibility.
   Water-skiing and other towing activities are prohibited after sunset and before sunrise and in periods of reduced visibility
- b. Efficiency of Sewage Systems Impinging on Waterbodies: Where sewage systems impinge on a waterbody, the municipalities which border the waterbody ensure that all such sewage systems are efficient; educational programmes be designed to reduce and eliminate entry of undesirable agents into waterbodies; surveys be conducted to determine inefficient sewage systems and corrective actions required.

**Motion:** That the ARLA/CRLSN motion of Spring 2000 concerning Sewage Systems be sent to the Townships of Rear of Leeds and Lansdowne and Rideau Lakes with the comment that LBLA would be pleased to hold discussions with township representatives.

Discussion: Kirby: seasonal residents get few services for the 70% of the tax base they contribute;

Willemsen: said she thought the Health Unit is responsible for septic systems in municipality of R of L & L

[However, Rideau Lakes Township has direct responsibility for them.]
Timmings: Suggests there should be by-laws to govern septic systems

Kilpatrick: RVCA expressed concern of problem systems being passed on. Archipelago Twsp. categorized sewage systems as high, medium or low risk and as necessary acted to control them.

Paul Smith: should press legal profession in proper selling of cottages: building permits, rights of way, septic

c. Pre-season bass fishing: eliminate cast and retrieve fishing - May 1 to season opening. Kilpatrick to forward suggested regulation to MNR through ARLA and/or CRLSN. Notes: it would be a LONG process.

### 15. TOWNSHIP COMMUNICATION:

Amendment notice to ratepayers regarding prepayment of 2000 taxes. Copies distributed at this AGM.

### 16. OTHER ITEMS OF INTEREST:

New Delta town dock: comments - excellent installation

Sewage System/Shoreline Survey Status: Funding to LLGreen has been cut - no surveys to be conducted in 2001.

Kilpatrick to inform people concerned.

Take a Little Lead Out: C Angermann: Jim Wing thinks this is not necessary. Membership wants to continue. Angermann will apply for funding from MNR. Jeanne Patric expressed interest in helping.

Osprey nesting platform implementation: one will be placed in LBL park, another in Morton area in the Fall.

Loon nesting platform: F. Ellis volunteers to help in 2 years. Can combine application for grant from MNR with Get the Lead Out.

### 17. LBLA WEBSITE:

Major undertaking by Neil Herber and Jan Reatherford. Al Brown suggested that minutes and Treasurer's report be posted.

### 18. ANNUAL GENERAL MEETING 2001:

Motion: To have meeting same time/place as this year. Angermann/M Santos Carried

Discussion: Doug Kilpatrick noted that 64% wanted Saturday meeting in 1998, aren't we excluding weekenders.

Turnout good tonight. Maybe Saturday evening. Griffith suggests something in newsletter registration form to express concerns to be brought to the AGM.

Angermann: Jet Ski problem ruining the lake

Discussion: Ellis: there's no pressure on them, need constructive dialogue, they're intolerable Griffith: members should volunteer for boating survey -- bad boating behaviour reports

Timmings: Are they banned anywhere? Response: only in Provincial Parks

Kilpatrick: In New York, authority has been given to municipalities to ban PWCs on waterbodies

8.a. Safe and Considerate Boating Events at LBL Park. Doug Kilpatrick:

These grew out of the motion at the LBLA 1999 Annual General Meeting to approach the LBL Township Park administration to ban PWCs from launching at (the) park.

Meetings were held on 05 Aug and 11 Sep 1999. Representatives from the townships were invited but were unable to attend. Two Sergeants from the OPP attended. Twenty-one people from the LBLA were invited and seven attended.

It was decided that attempting a ban on launching of PWCs from the park was not feasible. Rather, EDUCATION IN THE SAFE AND RESPONSIBLE OPERATION OF ALL TYPES OF WATERCRAFT should be the first step and that D. Kilpatrick would co-ordinate it.

With the assistance and advice of the OPP, over the Autumn of 1999 and the Winter of 1999-2000, a core group of LBLA members produced the three publications:

SAFE AND CONSIDERATE BOATING,

REPORTING OF BOATING BAD BEHAVIOUR,

DATABASE OF WATERCRAFT OPERATED ON LOWER BEVERLEY LAKE & CREEKS.

It was decided to distribute these publications and obtain information through

The LBLA Annual Newsletter package, and Safe Boating Events on peak arrival weekends at LBL Twsp Park.

The objectives of the Events were/are

To disseminate information, including the Safe Boating Guide,

To gather data about all types of craft operated on LBL & creeks, To show to the public that the OPP and the LBLA care about Safe

and Considerate Boating on LBL and its creeks.

First Event: 20 May 2000.

OPP provided two officers and one cruiser. LBLA volunteers: Five.

Unfortunately the weather was very cloudy and cold, so arrivals at the park were below normal.

First Event: (cont)

We stopped 24 cars, 15 of which were boaters, gave them the information and collected eight sets of data.

Second Event: 01 Jul 2000.

OPP provided three officers and three cruisers. L3LA volunteers were five although two who had said "yes" were unable to attend.

The weather was so good that the park was full. There was next to nil traffic arriving. Therefore three teams of one OPP officer and on LBLA person circulated through the park, distributing information, collecting data and "showing the flag".

It is estimated that 50 sets of informationwere distributed. Twenty-two sets of data were collected.

Third Event is scheduled for 05 Aug 2000. If it is rained out, we will try for 02 Sep 2000. ?Any volunteers for 05 Aug 2000?

The persons who have participated consider the exercise to be of value. Although we have not made the number of contacts for which we had hoped, we are showing that we care about safe and considerate boating.

FISH AND WILDLIFE GUARDIAN PROGRAMME. Doug Kilpatrick.

Doug Kilpatrick learned of the F & W Guardian Programme at the Autumn 1999 meeting of the Alliance of Rideau Lakes Associations. He obtained details and application forms from MNR and sent them to 12 members of the LBLA who, on their Registration Forms, had indicated interest in Wildlife. Three members applied. One person was accepted for the training course and passed the qualification exam. This is Ted Brett, who passed first in his class!

The F & W Guardian Programme was instituted to in part compensate for the reduction in Conservation Officers resulting from the Provincial Government's reduced funding to MNR. It also provides another means for local groups to be pro-active in the care of local natural resources.

The Role of the F & W Guardian is to

- -- Aid Conservation Officers in upholding the Fish and Wildlife Conservation Act;
- -- Be positive and pro-active in giving information, answering questions on angling and/or hunting;
- -- Be visible and accessible to the public;
- -- Enforcement: Have no legal authority, Be non-confrontational,

Do NOT engage the public in any enforcement activity;

-- Be an Observer: Are trained to pass information to the Guardian Co-ordinator for possible enforcement.

"Uniform": When on duty, the F & W Guardian wears a clearly identifiable orange west and hat.

Anyone wishing information about Wildlife stewardship or to report a violation should postact / Crimestop-1-800-222-TIPS.

14.a. Safe Boating: Recommendation that Towing Sports CEASE at SUNSET, the Same Time as Navigation Lights Must Be Shown.

> At the Spring 2000 meetings of The Alliance of Rideau Lakes Associations (ARLA) and the Cataraqui Region Lakes Stewards Network (CRLSN) the following motion was passed:

- ... that in the interest of consistency and safety, the time of day and visibility conditions for Waterskiing and Other Towing Activities, as soon as possible, be made the same as for the showing of Navigation Lights.

    - -- In periods of reduced visibility.

14.b. Sewage Systems -- Ensuring Efficiency of those which impinge on water-(SEE HANDOUT.)

At the Spring 2000 meetings of ARLA and CRLSN, the following motion was passed:

- That the Alliance of Rideau Lakes Associations (ARLA) (( Cataraqui Region Lakes Stewards Network (CRLSN) )) strongly recommends that where sewage systems impinge on a waterbody, the municipality/ies which border the waterbody ensure that all such sewage systems are efficient, and
- that through co-operation between the municipality/ies and such as lake and/or property owners' associations, there be
  - -- educational programmes designed to reduce and eliminate the entry of undesirable agents into waterbodies, and there be
  - -- surveys conducted to determine inefficient sewage systems, and there be
  - -- corrective action, as warranted, required by the municipality /ies, and
- that in the case of new construction or alteration of an existing structure or change in the ownership of a property where there is a structure, the municipality/ies use their authority to ensure that the sewage system is efficient, and
- that individual associations within ARLA ((CRLSN)), as soon as possible, comunicate this motion to the respective relevant municipality/ies.

14.c. Bass Fishery Protection: Pre-season and During Spawning: RECOMMENDED CHANGE IN REGS.

(SEE This item comes from the meeting of 17 Jun 2000, concerning the

HANDOUT.)Fishery on Lower Beverley Lake. The meeting supported the proposal.

At the date of writing this, Doug Kilpatrick had not been able to contact the person who proposed the new regulation. What is recorded below is from Doug's meeting notes and may require correction.

The intent of the proposed additional regulation is to protect bass -- from pre-season fishing, and -- while they are spawning.

The new regulation might look something like:

In the period 01 May through 15 July, no person shall angle the cast and retrieve method in water which is less than 20 (twenty) metres from shore.

LBLA

(The distance indicator makes it easiest for Conservation Officers and F & W Guardians to apply the regulation.)

The proposer is to draft the regulation change and "run it by" the Area Biologist, MNR Kemptville.

D. Kilpatrick is to (try to) forward the regulation change to the Minister of Natural Resources through ARLA and/or CRLSN. This would lend more weight to the proposal.

It would probably be made to apply to Southeastern Ontario, Map B in the Regulations.

It would be a LONG process.

15. Payment of Property Taxes in TOWNSHIP OF RIDEAU LAKES:

(SEE The METHODS OF PAYMENT were clarified in a memo from the Twsp of Rideau Lakes dated July 4, 2000.

Copies of the memo were made by Doug Kilpatrick for this AGM.

16.a. Sewage System / Shoreline Survey Status: Doug Kilpatrick:

On 05 Jul 2000, Leeds and Lanark Green Community advised D. Kilpatrick that they had not received funding for the year 2000. Therefore, for those people who, in 1999, had requested a survey but one was not done, and those people who, in 2000 had requested a survey, will not have one done in the forseeable future. Names will be kept on file and action taken when and if possible. Kilpatrick will so advise the people concerned.

16.c. Osprey Nesting Platforms Around LBL: Doug Kilpatrick:

In Feb 2000, D. Kilpatrick learned that Leeds County Stewarship Council had received an EcoAction grant for the erection of Osprey Nesting Platforms. D. Kilpatrick requested that at least one be placed placed in the LBL area. It has been confirmed that one will be placed in LBL Park, as far as possible from noise, yet visible to public viewing. Another will be placed in the Morton area. They will be placed in the Fall of 2000.

### 14.c. BASS FISHERY PROTECTION BY ADDING TO THE REGULATIONS:

This recommendation was supported by the LBL Fishery meeting held 17 Jun 2000.

The intent of the new regulation is to protect the bass fishery by reducing the impact of -- bass being taken before the season opens, -- luring guard-fish off the nests during spawning.

The new regulation might look something like:

In the period 01 May through 15 July, no person shall angle the cast and retrieve method in water which is less than 20 (twenty) metres from shore.
